Crosscheck is in its 10th year of existence. Recently we have expanded our athletic program to include a new sport (soccer) and reached 120+ Latino players from the Hickory Hill neighborhoods. Crosscheck has maintained and grown our Memphis footprint, bridging the suburban and urban gap through athletics, by developing and sustaining relationships with north and south Memphis teams, Frazier, and Binghampton schools, organizations, and teams. The urban representation in the 2016-2017 football season alone equates to 25% participation. The purpose of this grant is to continue expanding our urban, relational footprint. We have had 9 years of successful offerings for flag/tackle football, basketball, baseball, and soccer for ages 6-13.

Team and community pride is fostered which impacts their own communities.
